- 1. The labor association for studies and employment (Shiraa) had in cooperation with the holy land Christian society given out gas containers and cockers to unemployed workers on March 25.2003.
- 2. Organizing a one-day workshop on the topics: the international human law and the international Red Cross and the crescent organizations. Thirty workers participated in the workshop which was organized in cooperation with the Palestinian cross society.
- 3. Organizing a first aid course for seventeen Palestinian workers. The course, which included both theoretical and practical lessons, was organized in cooperation with the Palestinian health relieve committees.
- 4. Organizing occupational rehabilitation courses for Palestinian workers. The courses, which were organized in co operations with the Palestinian occupational training center, included professional cocking and satellite dish installation and maintenance.
- 5. Organizing a computer and internet courses in cooperation with Ibdaa' cultural center. Seventeen Palestinian workers benefited from the course which began on April 21.2003.
- 6. The labor association for studies and employment (Shiraa) issued a press release marking the first of May that was distributed among workers in Bethlehem district.
- 7. The reception of a British workers Delegation from Birmingham State, included Medical careers workers Union, and they were put on the image of the situation of the workers in Dheisha Camp on 25.1.2003.
- 8. Participation in the reception of Minister of the Interior Hani Al-Hassan with the other NGOs and associations in Dheisha Camp.
- 9. The participation in a lecture, which was divected by the Prisoner club about the jails and the prisoners and the shame rooms. This lecture was held at the women Union in Bethlehem.
- 10. The participation in all the sit-ins which were directed by the Palestinian Prisoner club to support the prisoners.
- 11. The Participation on all the marches in Bethlehem Governerate to support the President.
- 12. The participation in solving several problems in Dheisha camp , and visiting the martyers' families , and martyers graves, too ,
- 13. The working on making Data in Bethlehem Governerate for the workers .
- 14. Solving the problem of the workers of "AN-NJASSA FACTORY" by a fair settlement .
- 15. Solving the Problem of one of the workers in Al- Asdegaa Factory  $^{\circ}$  and an other worker in Al- Moheet Company .
- 16. The meeting with the Greek Caravan of Solidarity Delegation with the Palestinian People in the Greek Palestinian Friendship Association .
- 17. The participation in the formed Committee from the Deheisheh camp Establishments to resume the services introduced by the UNRWA.
- 18. The participation in sit-in in front of the UNRWA in Deheisheh camp with a large number of workers with the rest of the establishments to protest against reducing the services in the UNRWA on 1.1.2003.
- 19. Forming an emergency team and First aid included "30" workers in Deheisheh amp .And starting a course of First Aid with the co-operation with the Medical Relief; and training on leaving with the co-operation with the Civil Defense on 11.3.2003.
- 20. The participation in the with the establishments in Ibdaa center, one of the participants was Liam Maskey from Ireland. He is the director of the inter comm. Association in north Pelfast on 23.2.2003. by the invitation of REACH & the N.D.I.
