




























1. Shiraa' had set up a union that contained all labor committees of Bethlehem district municipalities and establishments. Shiraa' has also supervised elections of fifteen members to the above union from all local establishments on January 1, 2005.
2. Shiraa' general board of directions had debated the administrative and financial reports in addition to the activities, motions and interruptions. The debate had been attended by the following figures:
 - Ibshara Do'oud: deputy- governor
 - Saqir Sulaiman: agent of the interior
 - Khalil Abu Nijma: head of Labor union of local establishments
 - Hassan Al- Laham: director of Khaima cultural center

Nine candidates had completed for seven seats of the board the winners were the following: Husien Al-Hroub: 33 votes, Jamil Hamamreh 28, Munira Rizquallah 26, Khadir Azzghri 18, Issa Harb 18 and Haitham Zahran 17.

-  On April 24, 2005, Shiraa' circus group had displayed some acrobatics on the playground of Y.M.C.A in Beit- Sahour. A considerable number of children, foreigners and citizens attended the show.
-  Again, Shiraa' circus group had displayed some acrobatics on the open day made at Deheisheh basic school on May 31, 2005.
-  On May 19, 2005, Shiraa' board had visited Marco Zaidan's heritage center, had a look at her works of art and debated with her about ways of cooperation with Shiraa' women department.
-  On May 25, 2005, Bethlehem governor had debated with Shiraa' board about the issue of unemployment, labor concerns and the responsibilities of the govern rate of workers.
-  On May 30, 2005, Shiraa' board had also debated with a group of American journalists about the low standard of living on the part of Palestinian laborers and refugees.
-  "ALOUS" international circus and Shiraa's circus had made four- day joint show at Deheisheh basic school on May 2005.
-  On June 7, 2005, UNRWA women psychologists has debate with Shiraa' board about " civil marriage".
-  On June 6, 2005, the German circus (Kabafachia) had trained Shiraa's circus group for two days.
-  On June 16, 2005, a group of youth (ICAHD) had toured the camps of Bethlehem and then debated with Shiraa' about all aspects of suffering by Palestinian youth.
-  On June 16, 2005, Shiraa' had delivered a speech and then conferred degrees at the commencement of the second group from Al-Mahid Art Center.
-  On June 20, 2005, Shiraa' and UNRWA has debated the problems of refugee workers. UNRWA then, pledged to takeover employment of Palestinian workers.
-  In order to alleviate Palestinian youth's suffering arising from difficult conditions of living both Shiraa' and UNRWA psychologists had established a workshop from youth coming from working families on June 22, 2005.
-  On June 24, 2005. Shiraa' had made a cultural entertaining party that included a variety of activities: singing, acting, folk dancing and poetry reciting. Shiraa's friends, supporters and members attended the party at Deheisheh boy's basic school.

- 📁👤 In order to meet counterparts taking the same program, Shiraa' has made a journey to Jericho on June 26, 2005, for all the children taking popular education program.
- 📁👤 On July 1, 2005, Shiraa' and UNRWA psychologists had established a six-day workshop for ten workers about labor needs and psychological rehabilitation. By the end of the workshop, the workers were given jobs.
- 📁👤 Again, on July 1, 2005, a workshop on "early marriage" had been established by Khaima cultural center in the summer camp made at Irtas girl's school.
- 📁👤 On July 2,3,2005, a group of American opposing the apartheid wall had discussed with Shiraa the situations of Palestinian people in general and workers in particular, in addition to the other activities carried out by Shiraa'.
- 📁👤 A party that included acrobatics, folk dancing, acting, singing and playing musical instruments had been made for the aforementioned group on July 7,2005 after that, the visitors looked at embroidery and then had dinner prepared by Shiraa' women department.
- 📁👤 On July, 5, 2005, UNRWA women psychologists as well as Shiraa have established a six-day workshop for 10 workers about psychological rehabilitation and needs of youth.
- 📁👤 On July 13, 2005, Shiraa and Sulaiman Abu Dayya, director of the German establishment, Fredrich Freeman, had debated ways of granting aid to Shiraa.
- 📁👤 On July 19, 2005, Shiraa had discussed the role of Palestinian women in society with Canadian female writer interested in Palestinian women affairs. After that, the writer had a look at some home made productions (embroidery, pickles, etc) prepared by Shiraa women department.
- 📁👤 The problem of the female teacher Munira Rizqullah with Mr. Mazin Abu Isbaih has been solved on July 7, 2005. The former would give the sum back in installment.
- 📁👤 On July 23, 2005, Shiraa's band sang the anthem closing festival of "The Inventive Child" summer camp made in Hebron.
- 📁👤 On July 27, 2005, the "Re-building" program broadcasted by Bethlehem T.V. had an interview on "Waste and Solid Materials" with the children taking popular education course given by Shiraa.
- 📁👤 On July 25 2005, Shiraa had debated with the catholic relief organization about ways of granting aid to Shiraa.
- 📁👤 Gratuitous strengthening courses on basic subjects had been given by Shiraa for poor laborers children during the summer vacation of 2005, (June, July and August).
- 📁👤 On July 30, 2005, Shiraa had honored handicapped graduates in the second friendship carnival made by friend's society of the handicapped, in Al-Finiq Hall.
- 📁👤 The problem of the male worker Mohammad Shamroukh with the employer Issa Attalah (a factory owner) had been solved. The former's overdue fees had been obtained, on August 3, 2005.
- 📁👤 Backed by Shiraa, a free educational course for illiterate workers had been given by specialized teacher, on August 7, 2005.
- 📁👤 Backed by the USAID, Bethlehem cultural center as well as Shiraa established a workshop on the concerns and problems of Palestinian youth, on August 9, 2005.
- 📁👤 On August 10, 2005, Shiraa and Al-Haareh stage's boards had debated ways of cooperation between the youth departments of both sides.
- 📁👤 In participation of Arab Orthodox Club of Beit Sahour, Shiraa had honored foreigner's volunteers, on August 8, 2005, for their services in private establishments of Bethlehem.

-  On August 14, 2005, the problem of the female teacher, Munira Rizqullah with the private school of Nur-U-LBara' had been solved. The former's fees as well as overdue salaries had been obtained.
-  Supervised by Shiraa, a free Basic English course had been given for workers (beginners) by specialized teachers on August 8, 2005.
-  On September 9, 2005, Shiraa had acted a play and then delivered a speech on the open day made by Al-Ru'ya Palestinian establishment in Ibdaa's hall.
-  Held in Al-Finiq hall, Shiraa had supervised the elections to the Martyrs families' charitable society situated in Deheisheh camp on September 9, 2005.
-  On September 18, 2005, Shiraa had participated in poetry evening party made on Inad stage of Beit Jala.
-  On October 23, 2005, Shiraa youth department had organized a voluntary working day for cleaning the island and digging the garden along the main public road of Deheisheh camp.
-  On October 29, 2005, Shiraa had taken part in an open day made Bethlehem Hotel about the problems and misunderstandings between the police and the citizens on the one hand and about the responsibilities and duties of both sides towards each other on the other hand.
-  Shiraa's youth department had made a brochure on "Dangers of Waste to Society" and then distributed it to schools on October 31, 2005.
-  on the occasion of Lesser Bairam, Shiraa's as well as Al-Haareh's circuses had made a joint show on a lorry at the gate of Deheisheh camp on November 4, 2005.
-  in the party made on November 15, 2005, by Al-Ru'ya establishment, in Shepherd's Hotel, Shiraa had displayed some acrobatic, participated in the painting show and talked to Norwegian visitors about the concerns and problems faced by youth of local society.
-  On December 14, 2005, both Shiraa and the mother's committee of Deheisheh girl's school had debated with UNRWA competent authorities about "Night Duty".
-  On December 20, 2005, Ibdaa's and Shiraa's boards had debated the possibilities of making a journey to the destroyed Arab villages of the "Forty-Eight" for the children of Bethlehem camps.
-  Shiraa had debated with the welfare society and the National Insurance Company about the issue of health insurance related to the employees of Palestinian private establishments.
-  Finally, Shiraa is seeking steadily to maintain a new modern website.
